Plaintiff, the State of Vermont, hereby moves for an Order authorizing Plaintiff to file certain documents under seal in connection with the State's Motion to Rule Documents Discoverable and for Declaratory Relief, which is being filed simultaneously with this motion. In support of this Motion, the State states as follows:

- 1. The State has alleged that Defendants committed securities and consumer protection fraud in connection with multiple EB-5 projects in the Northeast Kingdom of Vermont. The Securities and Exchange Commission (SEC) brought a similar civil securities fraud case in the U.S. District Court for the Southern District of Florida. The Defendants' EB-5 projects and the now-pending EB-5 litigation have sparked significant public interest.
- 2. Plaintiff has filed contemporaneously herewith a Motion to Rule Documents Discoverable under 1 V.S.A. section 317(c)(14) and for related declaratory relief (the Documents Motion). To assist the Court in evaluating the Documents Motion, if the Court grants this Motion to Seal, Plaintiff will file with the Court as an exhibit the documents, stripped of personally identifiable information ("PII"), as defined by 9 V.S.A. §2430(5)(A) but containing other potentially private information such as the names and addresses of investors and other third parties.
- Vermont Rule of Public Access 7(a) authorizes the Court to deny public access to filings and proceedings in some circumstances, for good cause shown. V.R.P.A.C.R. 7(a) ("the Presiding Judge may seal from public access a record to which the public has access..."). In order to submit the documents for the Court's in camera consideration, Plaintiff requests an Order authorizing the filing of the sample documents under seal, thereby making the documents available to the Court.
